Introduction

This document serves as an Update to the Hunterdon County Coordinated County Human Services Transportation Plan, originally developed in 2007 and previously updated in 2009 and 2015.

The goals of this Update are to:

- 1. **Update demographic information** as available to evaluate potential changes in needs of transit needs of targeted populations- older adults, persons with disabilities, low income individuals, and veterans.
- 2. Evaluate current human services transportation needs.
- 3. **Update the "inventory" all available transportation services within Hunterdon County** to determine any changes in levels of available service.
- 4. **Review current Hunterdon County LINK Transportation System services** and provision of transportation in Hunterdon County relative to ridership trends, community demands, and expressed needs.
- 5. **Provide recommendations** on the consolidated approach to human services transportation to ensure coordination between all available transportation services with a key focus on providing these services efficiently and cost effectively and identifying additional services to meet community need.



Background

Coordinated versus Consolidated Transportation

The United We Ride mandate, as outlined in federal Executive Order 13330 (February 2004) seeks to increase *coordination* of human services transportation.

Hunterdon County has provided transportation for more than 30 years via the Hunterdon County LINK Transportation System using a "consolidated" transportation model. By its very nature, the consolidated model is based upon coordination. Agencies that are currently participating in the Hunterdon County consolidated model are listed in detail in the *Transportation Services Inventory* on page 39.

For the purposes of clarification and to inform this Plan Update, the following definitions* are used:

Consolidated Transportation – A fully integrated transportation system in which all individual units have been combined or consolidated into one integrated system, and individual agency identify for the purpose of transportation is no longer maintained.

Coordinated Transportation- A transportation system in which individual agencies are brought together, or act together in a concerted way, in order to provide for a smooth interaction of separate units of a program or system.

Executive Order 13330 (February 2004)

Directs multiple Federal departments and agencies to work together to ensure that transportation services are seamless, comprehensive and accessible.

In an effort to comply with the Executive Order, the Federal Transit Administration, the major funding source for NJ TRANSIT and therefore, county para-transit, is requiring that all recipients of FTA funds have a "Comprehensive Transportation Coordination Plan" in place.

Each county and/or agency receiving, directly or indirectly, FTA funds must do the following to comply:

- Designate a lead contact to work with the state in the development of a statewide plan.
- Convene a team to develop a local action plan and compose a county transportation coordination plan.
- Submit the plan to NJ TRANSIT and other related state agencies.
- Develop applications for grant funding based upon findings and recommendations in plan



2020 Plan Update Overview

Lead Person

The lead person for the 2020 Plan Update is Tara Shepherd, Executive Director, goHunterdon, the non-profit transportation management association (TMA) serving Hunterdon County. Tara Shepherd has a 20+ year-long working relationship with the Hunterdon County Department of Human Services and Hunterdon County LINK Transportation System. Cathy Taglienti, goHunterdon Community Mobility Coordinator, has been involved with the development of all prior plans and played an integral role in the development of this Plan Update by providing extensive data analysis.

Steering Committee

The Steering Committee for the development of this Hunterdon County Coordinated County Human Services Plan Update includes members of the Hunterdon County LINK Transportation Advisory Committee (TAC), agencies that provide transportation, human and/or social service needs, medical/health services, or receive funding through NJ TRANSIT. Hunterdon County Coordinated Human Services Transportation Plan 2007

Because Hunterdon County has operated the Hunterdon County LINK Transportation System as a consolidated system for more than 30 years, the recommendations outlined in the 2007 Hunterdon County Coordinated Human Services Plan, focused primarily on enhancing the existing LINK Transportation System rather than "coordination" efforts. The Plan recommendations, found in Chapter 5 of the Plan, were organized into three main categories:

- 1. Education and Outreach
- 2. Out of County Travel
- 3. Capacity and Operation Issues

Hunterdon County Coordinated Human Services Transportation Plan Update 2009

The 2009 Plan Update provided a status report on the progress of implementation of the 2007 Plan recommendations, identified changing conditions impacting efficient operations of the system and delivery of services to transit dependent populations. The 2009 Update also analyzed ridership trends and evaluated the financial constraints and opportunities for transportation in Hunterdon County for the next three years. The Plan Recommendations remained the same as the 2007 Plan.

Hunterdon County Coordinated Human Services Transportation Plan Update 2015

The 2015 Plan Update to the Hunterdon County Department of Human Services Coordinated County Human Services Transportation Plan provided updated demographic information, ridership data, and inventory of existing transportation services. The 2015 Plan Update identified key unmet needs, including out of county transportation particularly addressing destinations within adjoining counties (Somerset, Mercer, Warren), night and weekend service beyond the existing Flemington Shuffle service, improved routing for in county travel to reduce travel times (not to exceed 45 minutes), and the need for same day scheduling.

The 2015 Plan Update provided a sole recommendation: A full operational analysis of the LINK Transportation System including analysis of existing route configurations and schedules, review of ridership tracking procedures, analysis of ridership data by route, evaluation of operations management, and valuation of current and anticipated future funding to inform operational decisions.



Out of County Service Introduced: Route 23

Hunterdon County received a 5311 Innovation grant from NJ TRANSIT to begin operation of out of county service to neighboring Somerset County. Route 23 provides service from Flemington to Somerville, Monday- Friday, 7:00 a.m.- 6:00 p.m., including a stop at Raritan Valley Community College. The college is located in Branchburg, Somerset County but serves both Somerset and Hunterdon County students.

Modification of Demand Response Routes to Deviated Fixed Route Service

In March 2016, Hunterdon County modified four "demand response" routes to "deviated fixed route" service (Route 14, 15, 17, 18). A new Flemington Shuffle service, Route 16 was added to provide 'reverse' service of the Route 19 Flemington Shuffle to reduce passenger ride times.





New Dispatching Software/Same Day Scheduling

Hunterdon County implemented new "Ecolane" dispatching software in 2018. The new software system facilitated same day trip requests to be taken on a first come, first serve basis.










Senior 65+ Years Old Population by Town % - 2017






Hunterdon County Individuals with Disabilities % -2017 (10,830)








Persons with a Disability Demographic "Take-Aways"

Human Service Population: Low Income Persons






Low Income Population Ages 18-64 Dispersed Geographically


- Hunterdon County's poverty rate remains relatively low at 3.8%*

Human Service Population: Veterans

Hunterdon County has a veterans population of 5,641 (5.7%) with over 70% of veterans age 65 years old and over.

Access to healthcare is a challenge for most veterans. Veterans requiring preventative medical care need to travel to Lyons VA Medical Center, Lyons or East Orange Campus, East Orange. Veteran's needing urgent care service (non-emergency illness or injuries) can utilized the newly approved Hunterdon Urgent Care, Flemington, NJ.

Veterans Demographic "Take-Aways"

- Veterans comprise of 5.7% of the County's total population.
- 73% of Veterans are 65 years and older
- Veterans need access to out of county preventative medical care and in-county non-emergency medical care.






Hunterdon County Human Services Needs Assessment (2019)

A survey conducted as part of the 2019 Hunterdon County Human Services Need Assessment revealed that among respondents who indicated they did not have their own transportation, the majority relied on a friend or family member (63%), followed by the Hunterdon County LINK (58%), Uber/Lyft (40%), Agency Transportation (16%), Logisticare (7%), or Taxi (2%). Respondents were able to select multiple answers.

Ten percent (10%) of respondents indicated that they or a household member have need of transportation services. Additionally, ten percent (10%) of respondents indicated that they were unable to receive needed human services due to a lack of transportation to/from the needed service, with 9% indicating that they were unable to access healthcare services due to a lack of transportation.




Hunterdon County Community Health Needs Assessment & Community Health Improvement Plan (2019)

The Hunterdon County Community Health Needs Assessment and related Community Health Improvement Plan are collaborative efforts of Hunterdon Healthcare System (HHS) and the Hunterdon County Department of Health. The 2019 Needs Assessment and Community Health Improvement Plan were conducted in consultation with the Hunterdon Partnership for Health, a collaborative of more than 70 agencies, non-profit organizations, businesses, and other local stakeholders.

The objectives of the 2019 Hunterdon County Community Health Needs Assessment (CHNA) were to:

- 1) Develop a comprehensive community health profile that provides a snapshot of the health and healthcare-related needs of Hunterdon County residents
- 2) Identify and prioritize health issues/needs


FIGURE 32: Leading Factors that Reduce Quality of Life in Hunterdon County

- 3) Have a CHNA report that provides the focus for the Hunterdon Healthcare System and other community stakeholders for health and wellness improvement efforts. These documents have regularly noted the impact of the availability of transportation on quality life and health outcomes. See Figure 32, below, from page 73 of the CHNA Report 2019:





goHunterdon Non-Profit Survey (June 2020)

goHunterdon conducted a survey of Hunterdon County non-profit agencies and organizations to inform an updated inventory of transportation services as well as to identify transportation needs of human service clients. Key findings of the survey included:

- 18 Responses were received from non-profits
- Hunterdon County LINK was rated most affordable and most appropriate to meet the physical and developmental needs of clients
- Taxis were rated the most reliable (on time)
- Other key findings are as follows:









goHunterdon Private Practice Care Coordinator Feedback Survey (October 2020)

goHunterdon conducted a survey of Care Coordinators at Hunterdon County private medical practices to determine the need for transportation to medical appointments for seniors 60 years and older. The eleven (11) private practices that responded reported approximately 39,152 patients at their practices combined, 52% (22,242) were 60 years and older.



25% (5,656) of senior patients 60 years and older have a family member, friend or neighbor drive them to their medical appointments

35% (7,698) of senior patients 60 years and older can access a vehicle independently



Greater Raritan Workforce Development Area Plan 2016-2020

The Area Plan is an analysis of the local and regional economic conditions including existing and emerging in-demand industry sectors and occupations; and the employment needs of employers in those industry sectors and occupations.

The Area Plan identified that "transportation in the Greater Raritan Local Area is car dependent, reflecting suburban development patterns."

The Greater Raritan Workforce Development Board has, since 2012, identified the critical role that transportation plays in employment. The Local Area is served in Hunterdon County by goHunterdon, a federally supported Transportation Management Association.

In January 2016, goHunterdon and the Greater Raritan One Stop Center began "Needs Based Work Support" transportation assistance. The goal was to help individuals on public assistance find employment that was accessible by transit. goHunterdon provides transportation training to individuals who are looking for jobs. Classroom based and/or hands on trainings are conducted for WorkFirst NJ Job Readiness clients and WorkFirst TANF (Temporary Aid for Needy Families) clients. The goal of the travel training is to help clients expand their job search radius and identify potential job opportunities that are accessible by the bus and/or train.



Too often, job seekers apply for jobs for which they have no transportation to get to work once hired. This lack of reliable transportation jeopardizes sustained employment. Intra-county transportation, other than walking, bicycling, and car, is supported by county level transportation resources. With a lack of employment and population densities, such as those found in more urban environments, the costs of public transportation outweigh ridership potentials. While both Hunterdon and Somerset Counties locally sponsored transportation resources, operating hours/days are often geared towards the traditional Monday-Friday, 9 to 5 work day. The system does not adequately serve the second, third or weekend shifts at the low wage jobs in the retail, hospitality, healthcare, warehouse or food service sectors. These are exactly the types of jobs many of these clients secure.

Key "Take-Aways" from Plan, Survey Reviews

- Transportation dependent residents rely primarily on family and friends to provide for transportation needs.
- The Hunterdon County LINK Transportation System plays an important role in meeting the needs of transportation dependent residents.
- TNCs are playing an increasing role in the provision of transportation, particularly regarding transportation to medical appointments.
- The availability of reliable transportation impacts access to healthcare.
- Provision of transportation increased patient compliance and improves health outcomes.
- The availability of transportation, particularly early morning, evening and weekend service, has been identified as a barrier to employment.
- Increasing awareness of the availability of transportation services and how to access/use services should continue to be a priority.

Hunterdon County LINK Transportation System



The **Hunterdon County LINK Transportation System** is comprised of three (3) primary services:

- 1. **Shuffle Service** Seven (7) deviated fixed route bus routes, Monday- Friday: One (1) deviated fixed bus route, Saturdays, in the Flemington/Raritan area.
- 2. Demand Response Service- Monday-Friday, within Hunterdon County. Serving all Hunterdon municipalities.
- 3. **Out of County** services provided by Hunterdon County LINK bus Route 23 Shuffle to Raritan Valley Community College, Bridgewater Mall and Somerville Train Station.

Service Changes

In March 2016, Hunterdon County modified four "demand response" routes to "deviated fixed route" service (Route 14, 15, 17, 18). A new Flemington Shuffle service, Route 16 was added to provide 'reverse' service of the Route 19 Flemington Shuffle.

A new out of county service, Route 23, was also introduced on a pilot basis in March 2016. Route 20 Evening Flemington Shuffle service was discontinued.




The addition of a bus shelter provided by NJ TRANSIT was installed in January 2019.






Hunterdon County LINK Transportation Ridership Trends






LINK Ridership: Deviated Fixed Route Service

Other Transportation Services

Over the past five years, there has been an increase in the availability of Transportation Networking Company (TNC) services, specifically Lyft, as well as taxi services within Hunterdon County. The following provides an update on the status and use of these services.

Transportation Networking Companies (TNCs): Lyft Initiatives

Hunterdon Healthcare entered into an agreement with transportation networking company (TNC), Lyft, in 2018. The campus at Hunterdon Medical Center has been geocoded with designated pick up/drop off locations: Main Entrance, Emergency Department, and the Doctor's Building entrance. Patients and visitors may request rides using the Lyft app. Select departments within Hunterdon Medical Center are also scheduling rides on behalf of patients based on specific criteria.

In 2019, goHunterdon, the transportation management association management association (TMA) serving Hunterdon County, in collaboration with the Hunterdon Wound Healing Center (Hunterdon Healthcare), secured a grant from the Horizon Foundation to fund Lyft rides for patients of the Wound Healing Center that had been identified by staff as transportation dependent. Patient appointments and health outcomes are being tracked in addition to ride information.

The initiatives underway at Hunterdon Healthcare are addressing trips that are unable to be met by the Hunterdon County LINK System for a variety of reasons, including day, time, or physical/medical limitations of the passenger.

goHunterdon has a pilot project in development as of November 2020 to facilitate rides for human services populations for whom the LINK and other existing transportation services are not appropriate. The project will be funded by goHunterdon. This effort will be closely coordinated with the Hunterdon County LINK dispatch office to ensure that service is not duplicated.

Ridership data, including day, time, origin, destination, and rider profiles will be maintained to inform future transportation service planning.



Taxi Services

Taxi service availability has increased in Hunterdon County since 2015.

Taxi service information that is included in this Plan Update was obtained from the Borough of Flemington municipal office as "licensed taxi services". Additional taxis that are not required to have a municipal taxi license provided insurance documentation for verification of their service to goHunterdon.

In 2015, there were two (2) taxi services that were included in the plan.

Since 2015, there has been an increase to ten (10) taxi services.



Taxis play a growing role in providing service supplemental to the Hunterdon County LINK and TNCs. Taxi service hours include early morning, evening and weekends; hours that the Hunterdon County LINK may not operate. Same day requests for taxi service are accepted as well as advanced schedule service. The availability of taxi services improves options for residents. However, due to the high cost of fares, taxis are often an expensive transportation option in Hunterdon County. The average cost for a 12 mile taxi ride is \$43.70 compared to \$22.95 for a 13 mile Lyft ride and a maximum \$8.00 fare on the LINK. The cost of taxi and TNCs make these options unaffordable for many residents, especially older adults and lower income individuals.

Taxi service will continue to play an important role as a transportation option, despite the higher cost.

Key Unmet Transportation Needs and Gaps 2020

- 1. Out of county transportation to adjoining counties (Somerset, Mercer, Warren) on both deviated fixed route and demand response services.
- 2. Increased coordination with adjacent county transportation systems, including transfers outside of Hunterdon County.
- 3. Early morning, night and weekend service to meet the needs of low income workforce as well as seniors, persons with a disability and veterans.
- 4. Reduce travel time for all passengers
- 5. Transportation services to address employment needs, including shift workers
- 6. "Door to Door" service options for seniors and persons with a disability
- 7. More affordable transportation options or funding to subsidize rides
- 8. Ongoing public awareness of transportation options and how to access them.

Recommendations

- 1. Review transportation options for more out of county travel. Continue to collaborate with Somerset, Mercer, and Warren county transportation systems to facilitate transfers
- 2. Explore opportunities to address early morning, night and weekend service needs.
- 3. Leverage Ecolane dispatching software to reduce ride times on Hunterdon County LINK buses and/or identify alternate transportation services as appropriate (i.e. Lyft).
- 4. Continue to explore opportunities to improve rider experience, including leveraging technology.
- 5. Stay informed of emerging technologies for cost savings and efficiencies.
- 6. Review current LINK "curb to curb" policy and explore opportunities to revise as feasible or identify other services to address this need.
- 7. Maintain relationships and communication with agencies with clients needing transportation to solicit feedback.
- 8. Continue to use demographic and ridership data to inform Hunterdon County LINK operations and identification of other transportation services taking a "data driven" decision making approach.
- 9. Continue to identify supplemental services, such as TNCs and taxis, to complement Hunterdon County LINK service
- 10. Identify funding for supplemental services
- 11. Continue collaboration with goHunterdon TMA to provide transportation coaching, outreach and marketing of available transportation services.
- 12. Fill vacancies on Transportation Advisory Committee (TAC) using demographic trends to inform appointments.


